Kucharski: Something related, Lou talked about possibly having someone from DEP come in and do a presentation for us. From Arcea ... we certainly need a lot more information and this is simply to protect the Boroughs rights financially as far as the impact fee is concerned. Tanana: It has nothing to do with permitting or anything like that. The state has nothing right now for anything.
