To approve the Shimkus' lot's unification (Lots 31 and 32) in Schoolside Estates Phase II as recommended by the Throop Planning Commission.

On the question:

Tanana: Added that there is a \$2,000.00 per lot tapping fee for the Eddy Creek sewer line. Unifying those lots you have 2 separate sewer connections. Not sure if planning talked about that or anything. So it would be 2 connections.

Shimkus questioned why would need 2 connections?

Tanana replied because they are already there. There is one for every lot. We're unifying the 2 lots and they are already there. There will be 2 water hook ups, 2 electrical hook ups, because it's all underground utilities. It's all preinstalled from when he ran the gas and water lines. Tomasovitch questioned if they will have 2 gas bills and 2 water bills?

Tanana replied no. The water company will run one line and one they will cut off and cap. The electrical they won't tie into a box unless they are going to have 2-200 meter services on the house. That would be the only reason you'd have 2. But the sewer tap in fee is

Tomasovitch but they are only going to tap 1

Tanana right but that's already there. I'm saying there is 2 there. There is nothing stopping anybody from utilizing that one. All you have to do is dig down 6 ½ feet and tap into it. All the utilities were in there before they sold the lots.

Gangemi but it's not going to be utilized.

Tanana: There are a lot of people that live in phase I that have lots above them they've already talked about buying lots and unifying them with their lots. I'm just saying we're going to get a lot of this now.

Gangemi added that Kosik will have to decide if he wants to abandon it or whatever. We'll have to keep track of where the sewers are. They may have to abandon it and they may not. Have to just keep track. But I wouldn't charge him 2 tapping fees. Have to keep tabs on it. If there's a connection may want to terminate it so it doesn't cause problems. Especially 10 years down the road if an 811 call comes in. Needs to be in the records is all.

Cimini questioned if he is saying that he wants to amend the ordinance? Tanana: Yes. At a prevailing interest rate. A lot of years you won't get 5%.

Galli this is money that he paid in so he is entitled to it back.
